A. Project Title: 2014-01 Foxwood 2 Reorganization (Shasta CSD)

B. Description of the Project:

1. Reorganization of Territory: Resolution of Application from Shasta CSD for two boundary changes to bring uninhabited territory fully into the District for services.
2. Services: Domestic water, fire protection, and recreation services
3. Actions Requested: Annex territory into Shasta CSD with concurrent detachment of a portion of territory from Centerville CSD; consistent with adopted SOI boundary for Shasta CSD, and proposed SOI boundary for Centerville CSD. A tentative map with zoning and general plan changes is being prepared for submission to Shasta County, but first the parcel must be wholly within one water agency or the other. Sometime in the past the subject parcel was inadvertently split between both Districts. This action will correct that error, permitting the tentative map with zoning and general plan changes to be submitted for this parcel.
4. Territory Included: Parcel 204-650-0-01, 100% consent of landowners; 104.94 acres






