

SPECIAL DISTRICT RESOLUTION NO. 95-26

A RESOLUTION OF THE SPECIAL DISTRICTS BOARD OF DIRECTORS
OF THE COUNTY OF SHASTA
SETTING WATER RATE FEES FOR
COUNTY SERVICE AREA NO. 6 - JONES VALLEY WATER

Be it resolved that the following rates and charges are hereby added to the Fee Resolution, to be effective on November 1, 1995.

The Board of Supervisors of Special Districts of the County of Shasta ordains as follows:

SECTION 1. Fees for Shasta County Service Area No. 6 - Jones Valley Water, shall be as follows:

Basic Bi-monthly Charge: \$20.00

Variable Rate Schedule:

- (1) First 2,000 gallons included in Basic Bi-monthly Charge of \$20.00 (0-2,000 gallons);
- (2) A charge of \$0.16 for every 100 gallons or portion thereof for that portion of the total bi-monthly consumption, between 2,000 gallons and 12,000 gallons (2,000-12,000 gallons);
- (3) Thereafter, a charge of \$0.07 for every 100 gallons or portion thereof in excess of the first 12,000 gallons for that bi-monthly period.

Rate Schedule for Jones Valley U.S. Forest Service Campground:

Basic Bi-monthly Schedule:

- (1) First 20,000 gallons included in Basic Bi-monthly Charge of \$480.00 (0-20,000 gallons);
- (2) A charge of \$0.32 for every 100 gallons or portion thereof for that portion of the total bi-monthly consumption, between 20,000 gallons and 120,000 gallons (20,000-120,000 gallons);
- (3) Thereafter, a charge of \$0.14 for every 100 gallons or portion thereof in excess of the first 120,000 gallons for that bi-monthly period.

Standby Charge: \$5.00 per month (to be levied on all developable parcels not receiving water service).

Commercial Rate Schedule: Same as Residential Rate Schedule for first unit plus one additional Basic Bi-monthly Charge for each additional unit on the parcel.

Capital Improvement Fee: \$750.00 per unit (to be levied prior to installation of a new service).

Connection Fee: Actual cost

Reconnection Fee: Actual cost (\$25 minimum)
(Discontinued service)

SECTION 2. This resolution supersedes any prior ordinance or resolution setting water rate fees for County Service Area No. 6 - Jones Valley Water.


